BALTIMORE NEIGHBORHOOD INDICATORS ALLIANCE September 2009

1. Key Accomplishments Since April 2009.

BNIA-JFI releases Vital Signs 6 & 7 data for Baltimore City and its 55 Community Statistical Areas. Vital Signs provides the most accurate and reliable data that measure progress toward long-term results for strong Baltimore City neighborhoods, improving quality of life, and a healthy Baltimore City. Vital Signs 6 & 7 presents data through 2007. (September 2009)

2. Important Reports and Data Presentations.

BNIA-JFI releases Vital Signs 6 & 7 data for Baltimore City and its 55 Community Statistical Areas. Vital Signs provides the most accurate and reliable data that measure progress toward long-term results for strong Baltimore City neighborhoods, improving quality of life, and a healthy Baltimore City. Vital Signs 6 & 7 presents data through 2007. (September 2009)

BNIA-JFI has made several presentations relating to the Baltimore DrillDown and has created several tailored neighborhood data snapshots. These include presentations to Embrace Baltimore, Lauraville Main Streets, University of Baltimore – Real Estate and Economic Development Program, and the University of Maryland, Baltimore – School of Social Work.

BNIA-JFI provided data and mapping services to the Baltimore Community Foundation's *Baltimore Community Experience Initiative* (BCEI). A report detailing the findings from the data, maps, and information gathered from interviews, community meetings, and other sources was issued by the BCEI project team.

3. New Analysis/Program Efforts.

CEDS 2009 – BNIA-JFI will be updating the Comprehensive Economic Development Strategy indicators for the Baltimore City Department of Planning.

State of the Downtown 2009 – BNIA-JFI will be providing several analyses for the Downtown Partnership of Baltimore including an analysis of the economic impact of downtown employment and collecting the employment information of businesses in the downtown area.

The Effects of Foreclosure on Children, Schools, and Neighborhoods – BNIA-JFI is partnering with the Urban Institute and the Furman Center at New York University to explore the issues of children and foreclosures. This project will produce a detailed picture of the number of children affected by the foreclosure crisis. This research is being funded by the Open Society Institute.

BNIA-JFI continues to update the foreclosure filings map created for the Baltimore Homeownership Preservation Coalition. This map can be found at http://www.ubalt.edu/bnia/maps.cfm.

BNIA-JFI will be releasing Vital Signs 8 (and corresponding CSA profiles) in January of 2010. Vital Signs 8 will present data through 2008.

BNIA-JFI has recently begun to examine the dispositions of foreclosures and to identify new foreclosures in the former Baltimore Empowerment Zone for Associated Black Charities of Maryland.

4. New Data Acquisitions/Web Site Improvements.

BNIA-JFI issued an RFP for a redesign of its website. BNIA-JFI will shortly begin on a redesign of its website that will include both improvements to data visualization, data interactivity, and other content.

Camden

CAMCONNECT September 2009

1. Key Accomplishments Since April 2009.

Abandoned Properties

CamConnect recently partnered with the Camden Community Development Association (CCDA) with the goal of providing a more accurate count of the total number of vacant and abandoned properties in Camden. Abandoned properties continue to remain a large obstacle for the city's long-term redevelopment and economic stabilization plans. The municipal government, however, is not in possession of any comprehensive listing of such properties. Through various redevelopment studies and community organization's listings of target properties, CamConnect has made significant strides towards estimating the extent of the vacancy problem in the city. According to our most recent estimates, there may be as many as 9,800 vacant buildings in Camden which account for 35 percent of the city's structures.

Camden Health Database Work

CamConnect has continued its management of the Health Records Database in collaboration with the Camden Coalition of Healthcare Providers (CCHP). Since 2002, the database has expanded to incorporate records from over 100,000 individuals living in and around the city. The database consists of demographic, diagnosis, and charges and receipts information for any individual utilizing the in-patient and emergency room services of the three hospitals located in Camden. These records provide a concrete means for measuring the health and cost outcomes of intervention measures and the ability to track high-utilizer patients through the health delivery system. For the first time, we have geocoded the entire database. In addition to its work with the CCHP, CamConnect has joined forces with the Camden Citywide Diabetes Collaborative, using the database to support efforts to improve the quality of primary care and health self-managment to patients with Diabetes.

2010 Census

With the 2010 Census approaching, CamConnect has continued to advocate for a more complete count of the city's population. Using the Census Bureau's "Hard to Count" scores every Camden tract is considered hard to count, with most ranking in the top 10 percent of all tracts nationwide. CamConnect is working with other Camden based organizations and city government to encourage a higher response to 2010 census.

Executive Director Stephen Singer recently spoke at the 2010 Census Camden Office Press Briefing along with the mayor and several other city and state officials. 2. Important Reports and Data Presentations.

Executive Director, Stephen Singer, recently presented to the Camden Community Development Association as part of CamConnect's efforts to provide a more accurate estimate of the number of vacant properties in the city. The presentation focused on GIS analysis of zoning and ownership of the city's 28,000 parcels as well as analysis from a recent vacancy survey conducted by Camden Public Works.

3. New Analysis/Program Efforts.

We are analyzing a current citywide survey of resident perception of recovery and redevelopment progress under the state's municipal takeover legislation

CamConnect is also using GIS to analyze and present alternative station locations for a planned light rail line on behalf of a CDC in in one of the affected communities.

CamConnect is currently in the process of developing and securing funding for several new projects. The first project, Public Investment and Expenditures Mapping (PIE Map), will work to provide extensive geographic and demographic analysis of the inputs and outputs of social investment in the City of Camden. Through the creation of a database from billing and service records and geographically targeted funding awards, PIE Map would represent the first large-scale flow of funds analysis applied at the municipal level. The project's objectives will be to allow policy makers, funders, and ultimately, Camden citizens to answer questions about public expenditure, support services, and social priorities in a way that facilitates the evaluation of individual agencies and programs.

The second project, CamDenizen, would serve as a news aggregation and analysis website for the city of Camden. By creating a central platform for both current and archival news articles, CamDenizen will provide meaningful news and information that will allow individuals and organizations working in the Camden community to make more informed decisions. A core component of the project will be the ability to perform textual analysis of news articles over a designated period of time in order to visualize how perception of the city has changed.

• Website Developments

CamConnect's most recent website development has been the addition of a document catalogue that allows members to search a comprehensive listing of CamConnect and external reports in addition to relevant public documents. Utilizing the MIT <u>exhibit simile</u> javascript ajax framework, the new system provides an easy to use, dynamically filtering interface for browsing a large database of files, simplifying the organization of the website.

The second phase (the Datalogue)is a parallel version for all of the data currently in CamConnect's possession. Users will be able to see more clearly what data is available for analysis and public consumption. Once this phase has been completed, a flash-based interactive component will be employed to allow users the ability to visualize and manipulate data on the website in the form of interactive graphs and tables.

CamConnect sponsors an annual Data Fair designed to introduce CamConnect with other organizations working throughout the Camden community. Individuals who use data as a regular component of their work are invited to speak and share their experiences. The Data Fair takes place each year in December and could provide a valuable arena to showcase NNIP.

3. New Analysis/Program Efforts.

- Foreclosure walk-aways We have used automated screen scraping techniques to weekly write the contents of the Cuyahoga Court docket to a database. We are currently mining key phrases associated with foreclosure milestones from the docket to identify foreclosure cases where the bank has simply walked away. These cases are basically still open on a judge's docket, but not proceeding because banks are realizing that it is not in their best interest to continue foreclosure proceedings on low value property. We have two VISTA volunteers from CWRU's law school to assist in the final report.
- New foreclosure paradigm Our Pathways to Foreclosure report indicated that a high cost mortgage with represented over 80% of foreclosure filings when the report was completed in June, 2008. However, since the recession has hit Cleveland, we are now seeing more foreclosure filings on prime mortgages and in suburban locations. In Pathways to Foreclosure we looked at the mortgage product and forward to foreclosure. This new research brief intends to look at the foreclosure and work backward to the loan product. Basically, properties involved in 2009 foreclosure look different than those of say 2005-early 2008.
- New analysis addressing strategies for addressing poverty in a shrinking city. This work
 hopes to move beyond landuse issues in a shirking city to see what the implications of
 this are on social conditions and needs.

The objective of this tool will be to provide decision makers with valuable information on 1) services delivered by non-profits, 2) demographic characteristics about the regions they serve, and 3) giving patterns associated with services being delivered to the community.

 Piton is working with local partners to develop a housing affordability early warning system.

Through funding from the MacArthur Foundation, Piton is working with the Urban Land Conservancy, Enterprise, and the Denver Office of Economic Development to develop an early warning system to detect properties and more generally areas around transit hubs that are in jeopardy of losing affordability.

Piton is exploring partnering with The Denver Foundation and The Civic Canopy to develop a regional indicators project.

Piton is meeting with program staff from The Denver Foundation and the Civic Canopy to explore the potential of developing a Metro Denver Community Indicators project. The project would work with community, academic and business leadership to agree on a set of community indicators that would then drive action and decision making toward common, agreed-upon outcomes. As a reference point, the group is learning more about the Strive Initiative in Cincinnati, an innovative cross-sector collaborative that helps urban youth succeed academically from early childhood through college and enter a meaningful career. http://www.strivetogether.org/

- The Child and Family Policy Center continues to be the research and analytic partner, including specific work with the student record data base from the Des Moines Community School District. In addition, CFPC has worked to link Des Moines' work with national data collection work and activities.

Columbus

COMMUNITY RESEARCH PARTNERS (CRP) September 2009

1. Key Accomplishments Since April 2009.

CRP continues to work with the University of Massachusetts-Lowell and other founding members of the Open Indicators Consortium (including several other NNIP partners) to develop WEAVE (Web-Enabled Analysis and Visualization Environment). WEAVE software will power the next generation of our DataSource indicators website. CRP has partnered with the Mid-Ohio Regional Planning Commission to build DataSource 2.0, enabling us to expand the system beyond Franklin County to include MORPC's geographic coverage and data for the Columbus MSA.

CRP has been involved in WOSU's community outreach activities on the foreclosure issue. WOSU, a public media organization in the Columbus area, received a grant from the Corporation for Public Broadcasting for the above purpose. CPB looked to replicate KETC's (St. Louis) foreclosure outreach efforts. Throughout the summer, WOSU held and televised two town hall meetings and produced other informational videos and material. CRP's roles included: 1) advisory group member, 2) providing data and analysis, and 3) panelist in a town hall meeting.

COMMUNITY RESOURCE NETWORK September 2009

1. Key Accomplishments Since April 2009.

Making Connections Network (MCN) and **Community Resource Network** as an agent of MCN, piloted the Jefferson County Foreclosure Conciliation Program (FCP) in partnership with Jefferson County Circuit Court and other community partners. The FCP initiative is targeted at households currently in foreclosure in the Jefferson County Circuit Court.

The FCP provides an opportunity for Jefferson County Circuit Court to address the pressing backlog of foreclosure cases in the court system by creating new efficiencies among community partners and decreasing the overall number of foreclosure sales. The FCP is also designed to help financial institutions move with more certainty through the marketplace by requiring homeowners to provide detailed financial inventories before meeting with the lender.

The success of the FCP relies on a broad group of stakeholders. Circuit Court Judges, the Master Commissioners office, the Circuit Court Clerk's office, the Kentucky Housing Corporation, Louisville Bar Association, housing counselors (Louisville Urban League and Housing Partnership, Inc.), the Legal Aid Society, pro bono attorneys, Making Connections Louisville, Community Resource Network and local outreach workers and volunteers play critical roles in the process.

CRN has been integral to the process by building the FCP database. We began with the foreclosure complaints first filed in court, then mapped the complaints at the parcel level, created route maps for FCP outreach workers. We continue to develop the process, capturing data from the initial outreach through each step of the conciliation process. As a result of our work the community will have a rich body of knowledge both to measure results and inform the future. The database and its data are used by the stakeholder group to evaluate the program's effectiveness.

CRN has completed over 70 requests in 2009 in support of the Making Connections Network (MCN). The requests range from simple tables and dot maps to complex studies. They include work products such as large wall maps and data analysis reports for various neighborhood organizations in partnership with MCN, including Metro United Way, Habitat for Humanity, Legal Aid Society, Louisville Urban League, the Louisville Asset Building Coalition and Center for Neighborhoods.

CRN has produced data presentations including maps on the foreclosure crisis in Louisville Metro / Jefferson County, KY for local council members, court representatives and other civic leaders. We will continue to process the initial foreclosure complaints, track outreach and outcomes, analyze the data and produce presentations as more information is acquired through the FCP process.

CRN has produced report briefs on high school drop-out rates among students in the Making Connections neighborhoods of Louisville ("Making Connections Neighborhoods - High School Drop Out Rates"), resident participation and results of the annual VITA Campaigns (VITA Campaign 2007", VITA Campaign 2008" and "VITA Campaign 2009"), and demographic characteristics of Louisville's most vulnerable neighborhoods ("Neighborhoods in Distress").

3. New Analysis/Program Efforts.

There are several projects we have started this fall both within and outside the University.

- We will be wrapping up our work with the National Center for Arts and Technology next month. The first set of maps were citywide and used in a suitability analysis for locating a center. This round we will focus on an area of north Minneapolis and provide detailed mapping of the land use, transportation, community resources and LED data for the area.
- We have also begun assisting with a faculty-led research project looking at affordable housing production in the Metro area over the last ten years. We have mapped affordable housing production by city and will be running a series of spatial statistics and regression on these data.
- CURA will be doing asset mapping for the Cultural Wellness Center and Allina Hospitals
 as part of their Backyard Initiative. The project will include data collection on community
 health resources (both 'sick' and 'well' centers) and may lead to a web mapping
 application for community groups.
- Finally CURA is partnering with the Universities Chance program which seeks to involve students more in the neighborhoods surrounding the University. The first step in this project will be a updated inventory, survey and mapping of the businesses and commercial properties in the Cedar-Riverside neighborhood.

In addition to these projects it should also be noted that CURA is undergoing a strategic planning process scheduled to be completed this fall that will form future direction for the

Center as well as its individual programs – Community GIS being one of them. We are hopeful that there will be a renewed focus and attention on the importance of CGIS, an expansion of our resources, and a more defined mission for our work

4. New Data Acquisitions/Web Site Improvements.

Precinct level Voter Participation data has been collected and aggregated by Census Tract for Minneapolis and St. Paul. We have bi-annual data from 2000-2008. This data includes the total voting age population and the number of votes cast.

In October CURA staff will be presenting along with LISC at the seventh annual Community Indicators Consortium conference. We will be part of a panel discussion on neighborhood collaborations, cross-site indicator analysis and our work on the Sustainable Communities initiative.

DATAHAVEN September 2009

1. Key Accomplishments Since April 2009.

We have continued to develop our additional products, including:

- New Haven YouthMAP, an interactive tool that provides detailed information on the accessibility of the city's youth programs;

- DataHaven Barometer of Community Conditions, an interactive graphing tool to plot monthly information on the region (e.g., up-to-the-minute data on unemployment, food stamps, crime, homelessness and foreclosures), which has also been distributed citywide in a Community Foundation report on the economic downturn;
- New Haven Neighborhood Quality of Life Survey, a collaboration with local neighborhood associations in New Haven to develop a tool for civic engagement and measuring quality of life indicators, which will be rolled out in Fall 2009 and involve DataHaven within a series of data-focused Neighborhood Workshops in Feb. 2010;
- New Haven Health Data Atlas, a collaboration with the City of New Haven, Yale
 University and other health experts,; and

 tools, and hope to offer these tools through DataHaven in the near future.



The first, Key Findings on the Affordability of Rental Housing from New York City's Housing and Vacancy Survey 2008, summarized newly released data on New York City's rental housing stock from the Housing Vacancy Survey (HVS) The HVS data revealed a tightening of the rental market, a drop in homeownership rates, and persistent affordability challenges for New York City renters, more than half of whom pay more than 30% of their income on rent. The second fact sheet, An Opportunity to Stabilize New York City's Neighborhoods: A Fact Sheet on the Neighborhood Stabilization Program, summarized important new eligibility criteria for the federal NSP program, and discussed how best to target the limited resources available to stabilize neighborhoods hard hit by foreclosures.

Within the next month, we will release a white paper, summarizing the key policy recommendations that came out of our February conference, <u>A Crisis is a Terrible Thing to Waste: Transforming America's Housing Policy</u>. The white paper will identify opportunities to break down old policy silos and leverage the resources of multiple federal agencies to forge more effective connections between housing programs and transportation, environment and education policy. Also within the next month, we will release a new policy brief, <u>The High Cost of Segregation: Exploring Racial Disparities in High Cost Lending</u>, which looks at the relationship between residential racial segregation and subprime lending, nationally and in New York City. Keep an eye out for these releases.

3. New Analysis/Program Efforts.

We continue to make progress on our ambitious Preservation Data Project, which will build a critical new database with key information on HUD, LIHTC and Mitchell-Lama rental housing in New York City. This summer, we have been busy meeting with key stakeholders and building the database, which should be up in June 2010. We are constructing the database from scratch, and spent the summer uploading all of the HUD files.

We are also immersed in research on the following topics:

- Why Do Some Sites Remain Underdeveloped in Strong Markets? New York City's capacity to grow depends in part upon whether land that is now under-utilized can be developed to its full zoning capacity. We don't know enough about what causes some property owners to develop their land to the fullest FAR (floor area ratio) permitted by the applicable zoning, or about why some owners continue a current use when development to full FAR appears to make economic sense. We are gathering data and constructing models to identify which sites in the City currently are developed under the maximum permitted FAR, and to evaluate the characteristics of the properties, their owners, and the neighborhoods in which they are located. Using information gleaned from our data analysis, case studies and interviews and with owners and real estate professionals, we will construct a model that can predict which lots will build out and which won't, and will suggest policies that the City could adopt to encourage landowners to develop underused land.
- Foreclosure & School Performance: Foreclosures significantly disrupt the lives of children and families. The Furman Center is studying how this disruption impacts the school mobility of children from families who suffered foreclosure. By linking data from the NYC Department of Education to our data on foreclosures, we can examine whether children who live in properties that enter foreclosure are more likely after the foreclosure notice is issued to switch schools. For children who moved after a notice of foreclosure, we will look at the characteristics of the school they left, and the school to which they moved.
- Outcomes of Distressed Mortgage Borrowers: Once a borrower falls behind on payments, a variety of possible outcomes can occur. Some delinquent borrowers catch up with mortgage payments and remain in their homes, either on their own or through a loan modification. Others refinance or sell the home and repay the loan before foreclosure proceedings are completed. And some borrowers are unable to prevent the foreclosure process from progressing to an auction of the home. For policymakers, the likelihood of these various outcomes have important consequences. Will the property remain vacant? Will a new owner maintain the building properly, and will tenure change from owner-occupied to renter-occupied? The probability of a distressed loan following each pathway likely will be correlated with observable and unobservable characteristics of the borrower, property, neighborhood, lender or loan terms. By combining datasets on foreclosure filings, loan terms, loan performance, initial borrower characteristics, as well as physical and neighborhood characteristics of distressed properties, we will

examine which factors are correlated with the pathways and eventual outcomes of distressed loans in New York City.

• Better Understanding Neighborhood Change: In recent work, the Furman Center has found that neighborhood economic gain has become more common among poor urban neighborhoods around the country, but no work exists that sheds light on either the underlying factors driving these changes, or their consequences. Popular accounts of neighborhood revitalization frequently use the term gentrification, which implies a particular form of change. Simply put, the conventional view of gentrification describes a process through which the influx of higher income, white households (usually childless) pushes up rents and attracts amenities that cater to more affluent residents. As these changes occur, and housing gets more expensive, the original poorer (minority) residents are pushed out of an increasingly white neighborhood. This stylized story is both undocumented and likely simplistic. We in fact know very little about the underlying dynamics of neighborhood economic transition. Through the use of unique, nationally-representative Census data, the Furman Center aims to shed light on both the residential decisions underlying neighborhood change as well as the consequences of such change.

We have recently acquired point specific crime data for 2004-2008 as well as all of the Mortgage/Deed information for NYC.

King County Equity & Social Justice Initiative King County considers equity and social justice legislation

On July 13, the King County Council introduced Ordinance #2009-0245, regarding the adoption of an equity and social justice policy framework for the county. The legislation is designed to formalize King County's commitment to creating opportunities for all and adopts the vision that King County is a place of opportunity, fairness, equity and social justice where all people thrive." Highlights of the legislation include creating a strategic plan for equity and social justice that encompasses all branches of King County government, additional use of the equity impact review tool in policy-making and placing an equity lens on the 2011 budget process. The Ordinance has been sponsored four Council Members including a candidate for the County Executive. A full copy of the legislation can be found online at:

Nutrition Labeling Evaluation: We have completed data collection and begun analysis of baseline and follow up data on the evaluation of our nutrition labeling regulation, which requires fast food and chain restaurants to provide information on calories, fat, sodium and carbohydrates for menu items. Results will be presented to the American Public Health Association meeting in November, 2009.

King County Performance Measures: We updated the public health performance measures for the cross-departmental Aims High project. (see http://www.metrokc.gov/aimshigh/index.asp) in July 2009. Public Health measures include both community-level measures (e.g., years of healthy life), measures of disparities (e.g., death rates by race, poverty level and neighborhood, for all causes and major specific causes), and indicators of program performance.

2. Important Reports and Data Presentations.

- Our web-based Community Health Indicator report, which tracts over 65 population-level measures of social determinants, access to care, behavioral risks and health outcomes by age, sex, race, neighborhood and income/poverty, complete with maps, was released in September, 2009. (see http://www.kingcounty.gov/healthservices/health/data/chi.aspx). These data are used extensively by community based organizations and other data requesters, and is another source of comprehensive surveillance data on the health of King County residents.
- A presentation to the King County Board of Health, based largely on Community Health Indicators and Communities Count findings, emphasizing place-based disparities and strategic public health investments based on place, was made by the Public Health director in September.
- A special report on the risk of obesity in high school football players was completed.
- We completed an analysis of foreclosures in White Center, the local Making Connections neighborhood. The report addressed 6 questions:
 - What is the present level of foreclosure in White Center, compared to that in neighboring areas, the rest of King County, and in Washington State? This analysis used data on Notice of Trustee Sale from the County Recorders Office for 2007-2009.
 - What do the most recent HMDA data say about White Center's mortgage situation, updating the Urban Institute's analysis of subprime lending in the Making Connections (MC) neighborhoods through 2005?
 - 3) What is happening to houses that are foreclosing in White Center? This analysis tracked every foreclosed property in one neighborhood census tract using assessor and recorder data on refinances and sales.
 - 4) HUD's Neighborhood Stabilization Program data identify several neighboring Pierce County zip codes as having highest foreclosure risk in the state. We interviewed local housing experts to see what could be learned from Pierce County's experience.
 - 5) What is the condition of the rental market in White Center? We examined Dupree + Scott market reports on White Center rents and vacancies over time.
 - 6) Are new (2007-2009) loans defaulting in White Center? What types of loans? For this we used HUD's neighborhood Watch Early Warning System data on FHA-insured mortgages.
- We completed estimates of numbers and types of persons eligible for health, insurance, welfare, food and utility assistance benefits for the City of Seattle Human Services Department.

3. New Analysis/Program Efforts.

- A database of baseline measures to assess progress in equity across King County departments was developed by Public Health in collaboration with other departments. The measures will be used to track progress on inequities across 13 outcome conditions that include: family wage jobs/job training, community economic development, affordable, quality, healthy housing, quality early childhood development, quality education, healthy physical environment, community & public safety, neighborhood social cohesion, access to all modes of safe and efficient transportation, access to affordable food systems and affordable and healthy foods, access to parks and nature, access to affordable and culturally appropriate health and human services, and racial justice in organizational practices
- We are developing measures of environmental determinants of health, largely based on the built environment, as a pilot to assess and track population-level conditions in this area. We hope to make these new measures a routine additional tool in the measurement of population health status.
- As part of ongoing analysis of foreclosure extent and impact, we developed a method to identify condominiums and commercial properties in foreclosure. We now monitor levels of foreclosure in King County cities as well as in the county as a whole.

4. New Data Acquisitions/Web Site Improvements.

- We continue to make improvements to our Community Health Indicator website
- We began using mortgage loan performance data from the Neighborhood Watch Early Warning System database that tracks mortgage originations by location and lender.

5. Upcoming Events/Activities to Showcase NNIP.

St. Louis

Regional Housing and Community Development Alliance (RHCDA) September 2009

1. Key Accomplishments Since April 2009.

- Strengthened relationships with our St. Louis NNIP partners through regular meetings and social events and reached a deeper understanding of the data priorities and interests of our partners.
- Provided individualized technical assistance to nonprofit organizations across the region.
- Received \$100,000 in HUD funding to continue our data-driven technical assistance work with St. Louis area community organizations. This grant also represents the first time that HUD has funded us to work in Illinois, making our organization even more "regional."
- We are now "live" as the St. Louis partner for the National Community Stabilization
 Trust, enabling local jurisdictions to purchase foreclosed properties, and we have closed
 on approximately 20 properties.
- Completed an NSP-2 application, in partnership with the City of St. Louis and the National Development Council. The application included an analysis of foreclosures, vacancies, and market characteristics of St. Louis City, and will potentially result in additional funding to redevelop St. Louis neighborhoods.

NEIGHBORHOODINFO DC September 2009

1. Key Accomplishments Since April 2009.

- NIDC is the go-to source for foreclosure information and housing market trends in the District of Columbia.
- NIDC continues to provide comprehensive data indicators about the status of children and youth in the District, as well as provide information about the important role of nonprofits in serving children and youth in the District.

2. Important Reports and Data Presentations.

Since May 2009, we have released:

- On the Road to Adulthood: A Databook about Teens and Young Adults in DC (June 2009). This report was done in collaboration with a local DC youth advocacy group and provides comprehensive data indicators and analysis on the state of older youth (age 12-24) in the District and examines the role of area nonprofits that work with young people, their families, and neighborhoods.
- Foreclosures and Renters in Washington, D.C. (April 2009). This report, sponsored by the Annie E. Casey Foundation and using local administrative data from NeighborhoodInfo DC, documents the extent to which foreclosures in Washington, D.C., have occurred in renter-occupied homes and apartments. The conclusion outlines several policy options for helping renters during this difficult period.
- **Housing Monitor, Summer 2009** (September 2009). We recently released the Summer 2009 issue of the web-based *Housing Monitor* report. The report covers the trends in the home sales market as well as foreclosures in the city.
- Evaluation Matters: Lessons from Youth-Serving Organizations (September 2009). The World Bank's East of the River Initiative provided two years of technical assistance to help four District nonprofits develop the capacity to evaluate outcomes. This new Urban Institute report examines the agencies' progress and highlights the conditions and factors promoting and frustrating effective evaluation strategies.
